1. Mafinga Town Council has received funds from Road Funds and set aside for the Roads Maintenance (*Periodic Maintenance and Routine Maintenance*) during the **Financial Year 2016/2017**.

Interested eligible Tenderers capable to undertake the above mentioned works may collect the tender/Bid documents in **English** from the **Secretary, Tender Board, Mafinga Town Council P.O.BOX 76,MAFINGA** from 08:00 hours to 15:30 hours on Monday to Friday inclusive except on public holidays upon payments of **Tsh 100,000/=(Tanzania shillings one hundred thousand)** non refundable. Payment should be made in Cash to the Town Director's Office (Treasurer's Office)

All Tenders in **One(1) original** plus **Two (2) copies**, dully filled in sealed envelopes marked "....."(Name of the Tender) should be delivered to the address – **The Secretary Of Tender Board, Mafinga Town Council,P.O.Box 76 Mafinga – Iringa.** not later than **25th APRIL, 2017 on Tuesday at 10:00 hours.** Tender will be opened in Public immediately thereafter in the presence of tenderer's or Representatives who would wish to attend in the Council Hall at 10:00 hours.
6. Prospective Tenderers' should attach the list of plants and equipment owned or leased by the firm, technical personnel together with their CVs to be deployed for the works, program of works, certified copies of Valid Contractor's 'Registration Certificates, up- dated business license,TRA Registration for TIN and ERB issued for purchase tender documents (For more detailed please refer to the Tender/Bid Documents)
7. All Bids must be accompanied by the Bid Securing Declaration in the format provided in the bidding documents.
8. Its should noted that, late Bids, electronic Bid, Bid **NOT** received, Bid **NOT** opened and **NOT** read out in the public at the Bid opening ceremony shall not be accepted for evaluation irresspective of their circumstances
